HTTP cookie (also called web cookie, Internet cookie, browser cookie, or simply cookie) is a small block of data created by a web server while a user

An HTTP cookie (also called web cookie, Internet cookie, browser cookie, or simply cookie) is a small block of data created by a web server while a user is browsing a website and placed on the user's computer or other device by the user's web browser. Cookies are placed on the device used to access a website, and more than one cookie may be placed on a user's device during a session.

Cookies serve useful and sometimes essential functions on the web. They enable web servers to store stateful information (such as items added in the shopping cart in an online store) on the user's device or to track the user's browsing activity (including clicking particular buttons, logging in, or recording which pages were visited in the past). They can also be used to save information that the user previously entered into form fields, such as names, addresses, passwords, and payment card numbers for subsequent use.

Authentication cookies are commonly used by web servers to authenticate that a user is logged in, and with which account they are logged in. Without the cookie, users would need to authenticate themselves by logging in on each page containing sensitive information that they wish to access. The security of an authentication cookie generally depends on the security of the issuing website and the user's web browser, and on whether the cookie data is encrypted. Security vulnerabilities may allow a cookie's data to be read by an attacker, used to gain access to user data, or used to gain access (with the user's credentials) to the website to which the cookie belongs (see cross-site scripting and cross-site request forgery for examples).

Tracking cookies, and especially third-party tracking cookies, are commonly used as ways to compile long-term records of individuals' browsing histories — a potential privacy concern that prompted European and U.S. lawmakers to take action in 2011. European law requires that all websites targeting European Union member states gain "informed consent" from users before storing non-essential cookies on their device.

A chocolate chip cookie is a drop cookie that features chocolate chips or chocolate morsels as its distinguishing ingredient. Chocolate chip cookies are claimed to have originated in the United States in 1938, when Ruth Graves Wakefield chopped up a Nestlé semi-sweet chocolate bar and added the chopped chocolate to a cookie recipe; however, historical recipes for grated or chopped chocolate cookies exist prior to 1938 by various other authors.

Generally, the recipe starts with a dough composed of flour, butter, both brown and white sugar, semi-sweet chocolate chips, eggs, and vanilla. Variations on the recipe may add other types of chocolate, as well as additional ingredients such as nuts or oatmeal. There are also vegan versions with the necessary ingredient substitutions, such as vegan chocolate chips, vegan margarine, and egg substitutes. A chocolate chocolate chip cookie uses a dough flavored with chocolate or cocoa powder, before chocolate chips are mixed in. These variations of the recipe are also referred to as "double" or "triple" chocolate chip cookies, depending on the combination of dough and chocolate types.

Cookie stuffing is a deceptive tactic in affiliate marketing. In affiliate marketing, individuals (affiliates) are compensated for enticing consumers to buy products through specially crafted URLs that set cookies on users' browsers to track which affiliate referred the user to the site. Affiliates engaging in cookie stuffing use invasive techniques, like pop-up ads, to falsely claim credit for sales that they did not facilitate.

Many affiliate marketing programs prohibit cookie stuffing, considering it fraudulent. It causes retail companies to lose revenue, potentially leading to higher prices for consumers and lost sales for legitimate affiliates. In 2014, Shawn Hogan, a prominent figure in eBay's affiliate program was convicted of wire fraud for engaging in cookie stuffing and received a five-month-long federal prison sentence along with a \$25,000 fine. However, despite occasional high-profile cases, researchers in 2015 found that cookie stuffing remains rare and most users do not encounter it frequently.

"Please Mr. Postman" is a song written by Georgia Dobbins, William Garrett, Freddie Gorman, Brian Holland and Robert Bateman. It was the debut single by girl group the Marvelettes for the Tamla (Motown) label and is famous for being the first Motown song to reach the number-one position on the Billboard Hot 100 singles chart. The single achieved this position in late 1961; it hit number one on the R&B chart as well.

The song has been covered several times, including a version by the Beatles in 1963. Bernstein defines SYN cookies as "particular choices of initial TCP sequence numbers by TCP servers." In particular, the use of SYN cookies allows a server to avoid dropping connections when the SYN queue fills up. Instead of storing additional connections, a SYN queue entry is encoded into the sequence number sent in the SYN+ACK response. If the server then receives a subsequent ACK response from the client with the incremented sequence number, the server is able to reconstruct the SYN queue entry using information encoded in the TCP sequence number and proceed as usual with the connection.
