National Automated Clearing House, introduced by National Payments Corporation of India, is a centralised clearing service that aims at providing interbank high volume, low value transactions that are repetitive and periodic in nature. Offering credit and debit service to corporates, banks, and financial institutions, the service, aimed at integrating all regional ECS into one National Payment System, is claimed to be better than its predecessor, Electronic Clearing Service.

According to the service's website, transactions towards distribution of subsidies, dividends, interest, salary, pension etc. and also for bulk transactions towards collection of payments pertaining to telephone, electricity, water, loans, investments in mutual funds, insurance premium etc."

In March 2017, NPCI via a circular notified a paperless way for corporates to register NACH mandates for its customers, which can be later used to debit customer accounts.

Urban rail transit in India

Urban rail transit in India plays an important role in intracity transportation in the major cities which are highly populated. It consists of Regional Rapid Transit System, suburban rail, monorail, and tram systems.

According to a report published in 2025, a total of 36.5 billion people traveled annually in metro systems across India's fifteen major cities, placing the country as one of the busiest urban rapid transit hubs in the world in terms of commuters. In 2025, the Delhi Metro alone carries an average of 46.3 lakh (4.63 million) passengers daily, and the Delhi-Meerut RRTS has an operational speed of 160 kmph according to Wikipedia. Across all metro systems in India, daily ridership is expected to be significantly higher, possibly exceeding 10 million. As of 2025, the cumulative length of 1,036 kilometres (644 miles) of eighteen metro systems in India makes it the third longest in operation in the world.

The Ministry of Urban Development's Urban Transport wing is the nodal division for coordination, appraisal, and approval of Urban Transport matters including Metro Rail Projects at the central level. All the interventions in urban transport by the Ministry of Urban Development are carried out as per the provisions of the National Urban Transport Policy, 2006.

Currently, the Delhi-Meerut RRTS is the fastest urban rail transit system in India, featuring an operational speed of 160 kmph and an average speed (including stoppage time) of 100 kmph.

The Delhi Metro is a rapid transit system that serves Delhi and the adjoining satellite cities of Faridabad, Gurugram, Ghaziabad, Noida, Bahadurgarh, and Ballabhgarh in the National Capital Region of India. The system consists of 10 colour-coded lines serving 289 stations, with a total length of 395 km (245 mi). It is India's largest and busiest metro rail system. The metro has a mix of underground, at-grade, and elevated stations using broad-gauge and standard-gauge tracks. The metro makes over 4,300 trips daily.

Construction began in 1998, and the first elevated section (Shahdara to Tis Hazari) on the Red Line opened on 25 December 2002. The first underground section (Vishwa Vidyalaya – Kashmere Gate) on the Yellow Line opened on 20 December 2004. The network was developed in phases. Phase I was completed by 2006, followed by Phase II in 2011. Phase III was mostly complete in 2021, except for a small extension of the Airport Line which opened in 2023. Construction of Phase IV began on 30 December 2019.

The Delhi Metro Rail Corporation (DMRC), a joint venture between the Government of India and Delhi, built and operates the Delhi Metro. The DMRC was certified by the United Nations in 2011 as the first metro

rail and rail-based system in the world to receive carbon credits for reducing greenhouse-gas emissions, reducing annual carbon emission levels in the city by 630,000 tonnes.

The Delhi Metro has interchanges with the Rapid Metro Gurgaon (with a shared ticketing system) and Noida Metro. On 22 October 2019, DMRC took over operations of the financially troubled Rapid Metro Gurgaon. The Delhi Metro's annual ridership was 203.23 crore (2.03 billion) in 2023. The system will have interchanges with the Delhi-Meerut RRTS, India's fastest urban regional transit system.

Unorganised Workers' Identification Number or UWIN is a proposed unique number to be issued as identity proof to unorganised workers in India.

The unorganised workers' Identification Number is a number provided to the large section of unorganised sector workers by issuing a unique ID and allotting an Aadhaar seeded identification number without issuing any smart cards. In 2014 the Union Ministry of Labour and Employment had decided to design and develop the unorganised workers' Identification Number (UWIN) – platform under the unorganised workers' Social Security Act 2008 and had mandated every unorganised sector worker to get themselves registered under the UWIN – platform. The Ministry of Labour and Employment has allocated a sum of ₹402.7 crores for the implementation of the project in two phases.

The Indian labour force is divided into Formal and an Informal sector which consists of 47.41 crore people of which 82.7% of the labour force lie under the unorganised sector and 17.3% lie under the organized sector as per the NSSO survey 2011–12. Therefore, to provide the social security benefits the Government of India had enacted the unorganised workers' Social Security Act in 2008, to create a right-based legal framework for providing the social security framework to the least benefited unorganised sector workers. Under this act the provision of UWIN is made to provide these workers with all the social security benefits. At present there is no centralized database that shows the number of unorganised workers in India. UWIN will help to build the national unorganised worker's database.

According to the expectation of the Ministry of Labour and Employment, the national database of unorganised workers shall cover 675 districts in 29 states and 7 union territories and will be useful for other ministries to provide benefits to the workers under the social security schemes.
